Re: Market Goat Registration Procedures, Dates, and More

This packet contains information regarding market goat registration procedures, rules, and dates for the 2025 Shelby County Junior Fair.

If you know of new 4-H or FFA members planning to exhibit market goats, please pass along these procedures and dates. Information regarding entering market goats for exhibition at the 2025 Ohio State Fair is also enclosed.

Important Dates

- All market goats must be under the care of the exhibitor by **Sunday, May 4th, 2025**.
- Market goat entries are due on *FairEntry* no later than **Sunday, June 1st, 2025, at 4:30 PM**.
- Market goat mandatory tag-in and optional weigh-in will be held on **Sunday, May 4th, 2025**, from 12:00 to 2:00 PM on the Shelby County Fairgrounds.
- ALL livestock exhibitors (market and lactating species) MUST attend a Quality Assurance or successfully test out of QA to be eligible to compete at the 2025 Shelby County Junior Fair. Please visit <http://go.osu.edu/shelbyQA> for details about Quality Assurance.

Registration

- If market goats are **NOT** entered on *FairEntry* by **Sunday, June 1st, 2025**, exhibitors will **NOT** be permitted to show or sell market goats at the 2025 Shelby County Junior Fair.
- Junior Fair Board will take the required photo IDs for market goats and lambs at the mandatory tag-in/optional weigh-in on **Sunday, May 4th, 2025**.
 - ***Exhibitors will not be required to upload additional photos of market goats and market lambs.***
 - Exhibitors **ARE** still **REQUIRED** to make those market goat/market lamb entries on *FairEntry* by **Sunday, June 1st, 2025**.

Important Information

- Goats must be under one year old at fair. Milk teeth must be present at the time of check-in at fair.
- All male goats must be castrated and have NO testicular tissue: non-castrated goats will not be eligible to show.
- Does that will be shown in the Boer/Boer Cross Breeding Show CANNOT be shown in the Market Goat Show.
- Minimum weight for eligibility to show- 40 pounds; minimum weight to sell- 50 pounds.

Reminder: Prohibited Practices

- Adding any substance externally to build up, change, or alter the shape or conformation of the livestock, including by the way of but not limited to rope, false hair, graphite, hemp, and powders (ORC 901-19-33).
 - 1st and 2nd place in each class will be wiped down to check for powders.
- Using ice, ice packs, cold packs, or cold compresses internally or externally.
- Drenching of livestock at an exhibition is prohibited.
- Additional guidelines can be found by reviewing Ohio Revised Code 901-19-13 and Ohio Revised Code 901-19-33.

DUNF Forms

- Completed Drug Use Notification Forms (DUNF) are required for each animal shown at the Shelby County Junior Fair. Once again, the ODA will be requiring online submission of these forms. More information will be sent out prior to the fair.
- ALL animals MUST be **free** of **any** medication **prior** to submission of the DUNF **before** the animal crosses the scale at weigh-in for the 2025 Shelby County Junior Fair!

Ohio State Fair

- Entries are due online by **Saturday, June 21st, 2025, by 1:00 PM. Absolutely no late entries will be accepted!**
- You will be required to provide information for either your 4-H County Extension Professional or your FFA advisor.
- Entries can be made online at www.ohiostatefair.com (Exhibitors should keep their exact login information).
